Predsednik Republike Srbije Boris Tadić najavio je u Srpskoj akademiji nauka i umetnosti da će u narednih nekoliko godina u razvoj naučne i tehnološke infrastrukture u Srbiji biti uloženo blizu pola milijarde evra. Tadić je naglasio da je ulaganje u naučno-tehnološki razvoj jedna od najvaćnijih investicija u ekonomski razvoj Srbije, čiji je bitan element zaustavljanje „odliva mozgova“. Prema njegovim rečima, obezbeđivanje investicije u iznosu od 200 miliona evra predstavlja izuzetan doprinos razvoju naše zemlje i govor o drugačijoj vrednosnoj orientaciji države Srbije.

Srbija je na putu ka stvaranju konkurentne tržisne privrede. Trenutno je orientisana na poboljšanje efektivnosti svoje ekonomije, što podrazumeva završetak procesa restrukturiranja i privatizacije društvenih i javnih

The conference of the European Leadership Centre, which will be held in Bled in late May, will be a challenging event focusing on what European leaders should bear in mind to make a difference and contribute to a better Europe and a better world. How will the European business environment look after the crisis? How will energy and sustainability issues influence the future development of Europe? These are just some of the questions we expect to hear answers to on the conference in Bled, where InfoReview magazine will participate as a media partner.

InfoReviewmagazine was the media partner at the Eight Business Round Table with the Government of Serbia, which was held under the name "New Direction for Growth", where the Serbian Prime Minister Mirko Cvetković announced series of stimulative measures for reducing the growth of unemployment and raising economic activities.Cvetkovic

also announced fiscal incentives which will encourage the growth of domestic demand and attract investments in infrastructure, and added that the focus will also be on the promotion of efficiency of public enterprises and their investments, for which will be given state guarantees.

President of the Republic of Serbia, Boris Tadic, announced at the Serbian Academy of Sciences and Artsthat over the next few years around half a billion Euros will be invested in the development of scientific and technological infrastructure in Serbia.Tadic highlighted at the ceremony that these are among the key investments in Serbia's economic development, because in order to achieve such development, Serbia must stop the 'brain drain'. According to him, securing an investment of EUR 200 million is an extraordinary contribution to Serbia's development and it testifies that Serbia is committed to different value orientation.

Serbia is on the way of creating a competitive market economy. Its current focus is on the improvement of the effectiveness of its economy, which includes the completion of the process of restructuring and privatisation of social and public enterprises, as well as implementation of modern management, work, and business organization methods. "How do you contribute to the improvement of the business environment with your business operation and advocacy of the welfare of Serbia?" was the InfoReview's survey question, and some of the answers you can read in this issue.
